The Northern Sub-Regional Trust supports funding that provides enhancement of physical well-being and provides an opportunity for all Community members from our youth to the elderly to engage in positive and developmental activities within the Community environment.

Funding is available under two categories:

- 1) Community Sporting Clubs
- 2) Community Activities, Training Camps and Programs

#### 3.1 Community Sporting Clubs

##### Terms and Conditions

- Community sporting club applications are capped at \$1,000, including GST per application.
- Funding can only be used for equipment, uniforms and training camps (including travel and accommodation).
- Funding must benefit the Community as a whole.
- Funding must be for the enhancement of physical and emotional well-being.
- Applicants must provide details of how funds are to be used.
- Applicants can only apply once every three (3) calendar years.
- Funding must be paid to suppliers, not to individuals.
- Funding can provide for special sporting activities for the aged to assist with the types of physical limitations that can be suffered by aged persons.
- Funding cannot be used for operating expenses such as wages, rent or electricity.
- Funding must be used in the respective calendar year and will not be rolled over to the next year unless there is an approved application for an extension.
- Funding must be acquitted per the Grant Acquittal Policy and Procedure.
- Applications will be assessed on a case by case basis.
- Applicants must provide details / quotations of how funds are to be used.
- Funding cannot be used for administration / auspicing / facilitation style fees.
- Applicants must acknowledge the NSRT for its funding support.

### **3.2 Community Activities, Training Camps and Programs**

Applications are capped at \$10,000 and applicants may only apply once per calendar year.

#### **Terms and Conditions**

- Applications are capped at \$10,000 and applicants can only apply once per calendar year.
- Applications will be assessed on a case by case basis.
- Funding must be used for clinics, training or methods to educate/benefit members.
- Applicants must provide details of how funds are to be used.
- For youth programs, applicants' attendance at training camps or programs will be based on school behaviour and attendance.
- Funding must benefit the Communities of the Northern Region of the Western Cape.
- Funding must be for the enhancement of physical, mental & educational well-being.
- Funding must be paid to suppliers, not to individuals.
- Funding cannot be used for operating expenses such as wages, rent or electricity.
- Funding must be used in the respective calendar year and will not be rolled over to the next year unless there is an approved application for an extension.
- Funding must be acquitted per the Grant Acquittal Policy and Procedure.
- Funding cannot be used for administration / auspicing / facilitation style fees.
- Applicants must acknowledge the NSRT for its funding support.
