Funding is available under the following categories. Applicants may apply for funding for:

- 1) Outstations Feasibility Study
- 2) Outstations Establishment

### 3.1 Outstations - Feasibility Study

Traditional Owners of the Wik and Wik-Waya family groups can apply for this funding.

### **Terms and Conditions**

- Applications will be considered on a case by case basis.
- Applications are capped at \$35,000 per feasibility study.
- Traditional Owners of the Wik and Wik-Waya family groups can apply for this funding.
- The outstations are to be used by all family members (not individual people) during activities, including traditional activities.
- Outstations are not intended for individuals or select groups.
- WCCT staff will arrange the feasibility study to be undertaken by one of their preferred suppliers.
- All legislative and Council requirements must be adhered to.
- The SSRT must be acknowledged for their funding support.

### 3.2 Outstations – Establishment

### **Terms and Conditions**

- The purpose is to assist people living on Outstations.
- Funding must be for the necessities of life.
- Funding must improve the standard of living.
- Funding must not be used for commercial profit or money-making.
- Applicants are responsible for maintenance, upkeep and housing of items purchased.
- The property is used during organised activities (such as teaching traditional skills).
- Activities are run by Elders or Community groups dedicated to Indigenous culture.
- WCCT staff will assist with arrangements including quotes from a minimum of two (2) builders prior to approval of applications.
- Funding is provided to service providers/suppliers, not to applicants.
- Applicants must acknowledge the SSRT publicly for its funding support.
