## **FUNDING AVAILABLE**

The CSRT is committed to helping with the costs of supporting funerals for Traditional Owners and long-term partners of the Central Traditional Owner groups of the WCCCA region.

Funding is available for Funeral Assistance and Feasting.

### **Terms and Conditions**

A capped amount of \$11,150 (including gst) is available per grant, as follows:

- 1) Funding of \$6,500 will be provided for casket, transport of casket, flowers and Funeral Directors Fees ONLY.
- 2) Funding of \$650.00 is allowed for site preparation fees.
- 3) Funding of \$3,000 will be provided for food for feasting and pre-gathering before the funeral if required by the family.
- 4) Funding of \$1,000 will be provided for eulogy preparation service provided by the Western Cape Centre ONLY.
- 5) Funding for feasting will be provided for up to three (3) service providers/suppliers and not to individuals;
- 6) Successful applicants must nominate the service providers and amounts at least 48 hours prior to requirement;
- 7) Funding for food, single use consumables and serving utensils associated with feasting;
- 8) WCCT Finance Staff will liaise with the nominated contact person ONLY (see page 2).
- 9) Those who have passed must be members of one of the five Central Traditional Owner Groups, or their partner/de facto and have cultural ties;
- 10) Funding for long term or historical Community members will be considered on a case-by-case basis.
- 11) Cash contributions to individuals are not permitted, and payment must be made to the service providers/suppliers and not to individuals;
- 12) Approval for funding will be by the relevant Director and Chairperson / Deputy Chairperson.
