Welcome to this quarter's newsletter. In the coming months, our annual general meetings (AGMs) for the Sub-Regional Trusts will take place. All shareholders will receive official notices by post with the dates for their respective AGMs, and we encourage all shareholders to attend.

During Q2, the Trust updated its Grant Funding Guidelines, which are now available on our website along with revised application forms.

Our Finance Team have also been working closely with the Western Cape College to assist shareholders with Educational Bursary applications and will continue this support throughout the year. The team is available every Wednesday afternoon at the Napranum Council offices to help with forms or answer questions. Please note, the next bursary application closing date is 10 October 2025, with applications to be reviewed at the Q4 Sub-Regional Trust meetings in November.

Looking ahead, our Executive Team is preparing for Q3 community visits to Napranum, Mapoon, Aurukun, Hope Vale and New Mapoon. We look forward to meeting with community members to discuss important matters and to continue building strong connections.

The past quarter has been an eventful one, marked by the official notification of the Kangwinan Project—the planned expansion of the Amrun Mine towards Norman Creek, conducting final feasibility studies before planned construction in 2026.

The WCCCC has been working closely with our partner Rio Tinto to ensure that Traditional Owner visions and priorities remain central throughout this process.

In late August, the Environment and Heritage Sub-Committee took part in their annual land and rehabilitation tour across the WCCCA and Rio Tinto mining lease areas. This tour will provide important updates on rehabilitation progress, turtle monitoring, coastal rejuvenation projects, renewable energy initiatives, and weed management efforts.

I also look forward to visiting our signatory communities in September to hear directly from Traditional Owners and discuss matters that are important to them. I encourage everyone to follow our Facebook page, where we will share the finalised dates for these visits.

RIO TINTO WEIPA UPDATE



LAND AND REHABILITATION UPDATE

Beach Clean Ups: Ahead of the Turtle Management Program the Land and Sea Team joined with some of the Mine operators to conduct a beach clean up at Amrun. A full skip bin of rubbish was removed during their efforts.

Turtle Management Program: Starting in late August the Rio Tinto Land and Sea Team will begin an intensive 6 week campaign across all beach sections South of the Embley monitoring laying events, turtle species, nest predation and hatching events.







KANGWINAN PROJECT UPDATE

The Kangwinan Project continues to progress under a feasibility study, with construction potentially beginning as early as 2026. The Environment and Heritage Sub-Committee alongside Traditional Owners continue to meet with Rio Tinto to discuss infrastructure locations, cultural heritage impacts and employment opportunities surrounding expansion.



EMPLOYMENT AND TRAINING UPDATE

School Engagement: Over the past quarter, the Indigenous Employment and Development team has actively engaged with the community, participating in a range of events. Highlights include a Weipa Site Visit and Hands-on Trade session, AFL House Presentations, the Clontarf Careers Expo, the WCC Careers Expo, and a presentation at NPA College.

CLONTARF UPDATE

Over three days in Cape York, the Western Cape Clontarf Academy hosted 13 partners for a hands-on Partner Experience. Travelling from across Australia, guests joined students for academy tours, cultural activities, and camping at Pennefather. Highlights included fishing, sunset buggy rides, a PE lesson delivered by Year 9 students in Mapoon, and an alumni dinner with graduates and Year 12s. The trip concluded with a sunrise training session at Napranum PCYC, leaving partners with a stronger understanding of the Academy's programs and the connection between students, culture, and community.





NAPRANUM PCYC UPDATE:

During August, the Napranum PCYC celebrated National Student Volunteer Week, recognising the incredible contribution our young people make to the Napranum PCYC and the wider community.
